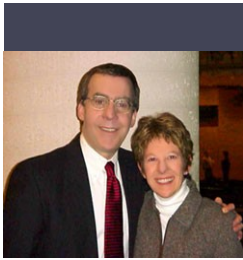

Beginning with the End in Mind: An Interdisciplinary Look at Families' Actual Needs During Divorce

The Ashers' will present four opportunities professionals can use their online resources to assist parents.

- ⇒ For judges, as a possible automatic referral
- ⇒ For mediators, prior to and during the mediation
- ⇒ For lawyers, to reinforce best interest concepts
- ⇒ For evaluators, to help move parents beyond their own hurt

Finally, the Ashers' will invite a discussion of the law's problem-solving tradition and the implications of elevating attorneys' practices and the law's processes in family cases to that tradition.

Their free online tools are designed to assist parents in separation and divorce crises and have earned considerable accolades, including the ABA Dispute Resolution Section's Lawyer as Problem Solver Award and the Association of Family and Conciliation Court's Irwin Cantor Innovative Program Award.
